Version 2.1.0.13 is ready to download! Today's release includes some top requested items, so get excited!

Welcome to cryptocurrency holdings. With the new **integration with Onramp**, you can obtain cryptocurrency holdings data. This is a new custodial interface for Panoramix.

Among the other listed enhancements is an email optout parameter to disable the New Documents to Portal notification emails on a temporary basis.

Notice on Windows 10 Version 20H2

Plan ahead!

Microsoft may end support for your operating system (OS) earlier than you think. Windows 10 version 20H2 servicing support ends in a mere 19 days. That means no more security patches for that version of Windows 10, making your environment vulnerable to exploitation.

Older hardware may not be able to upgrade to Windows 10 version 21H2, the latest (and perhaps last) version of Windows 10. All Windows 10 support ends in under 3.5 years—that's not much longer than we've been in the



pandemic times.

Incidentally, Windows 8.1 *extended support* ends in under nine months. You must be under a special Microsoft contract for this. If you are, we should know about it. Panoramix does no testing on the 8.1 OS.

Protect Against Potential Cyberattacks

On March 21, 2022, President Biden released a <u>statement</u> warning US companies of an increased threat level for <u>cyber-attacks from Russia</u>. In addition, the Securities and Exchange Commission (SEC) enforces identity theft rules commonly referred to as <u>Regulation S-ID</u> (17 CFR 248.201 – 202).

At Panoramix we take cybersecurity very seriously. We're continuing to do our part to comply with the president's urgent request.

Tips & Tricks for Panoramix

Did You Know?

Do you look at the cover page of your batch reports and wish you could add or subtract content, or even spice it up visually?

This you can do! If you are okay with not displaying the client name on the cover page (since it repeatedly appears within), you can design and build your very own custom cover page and upload it to Panoramix. Use any



program you're comfortable designing in, or a free web program, and create your own sparkling cover page. (You can contact Adeena, who has a background in design, for further tips.)

Just like how you add any other PDF to Panoramix, simply open the report group you want to add your cover page to, and click "Add" under the hamburger menu. Locate the file on your computer, upload, and move it to the front of your batch group. Ta-da! You now have a shiny cover page to catch the glowing eyes of your clients.
