# Panoramix 3.0.39 is Here: More Control, Better Web Tools

This release marks the beginning of exciting updates to the Panoramix Web experience. You can now customize your Advisor Dashboard layout online—choose which tiles you want to see the moment you log in. We've also added access to global report settings in Web, along with a series of fixes to improve report accuracy and third-party data settings.

Check out the full list of enhancements below.

- Implemented the first stage of enhancing Panoramix Web. A
  customizable Web layout is now available. Advisors may choose which
  tiles are displayed on the advisory dashboard when logging in to
  Panoramix Web.
- Added the ability to modify global report settings in Panoramix Web.
- Resolved an issue where generating a Portfolio Snapshot report on Panoramix web displayed only one account's data instead of the household's.
- Fixed an issue where the Schwab Settings in the Third Party Data Settings menu did not display correctly.
- Corrected an issue where the Asset Change Summary advisor report would return a blank report when a custodian was not selected.
- Resolved an issue where the amount displayed in the Cash Value field on Edit Account screen could not be set to \$0.

# In Case You Missed It: A Mid-Year Boost for Tax-Aware Planning







to Tax Loss Harvesting? Need Monthly Performance front and center? It's all up to you.




To make changes, just hop into the Panoramix desktop app and head to:

## Settings > Dashboard Layout > Web tab

Choose the tiles you want by dragging an item from the list on the right onto a tile, arrange them how you like, and click Save!

Next time you log into the web app, your dashboard will look exactly how you want it because your tools should work the way you do!


